

CVIM FOUNDATION MEETING MINUTES May 9, 2017

The agenda for the meeting was presented and the meeting was called to order at 7:08 pm.

Secretary's Report: Holly Bullard

Holly presented the minutes from the April 11, 2017 CVIM meeting. The minutes were approved as presented.

Treasurer's Report: Chuck Moore

Chuck presented the April treasurer's report. Chuck next presented for approval the budget for the 2017-18 fiscal year. The biggest change from last year involves the contemplated purchase of a truck, which CVIM will purchase and sell back to GUSD for \$1 in exchange for insurance. More specific line items have also been added so that we may track spending and needs more precisely.

Laurie Aronovsky moved to approve the budget. Anne Beglarian seconded the motion. A vote was taken and the 2016-17 CVIM budget was approved.

President's Report: Michael LeFevre

Michael recommended we have a student officer liaison to attend CVIM meetings so that students can be apprised of what the board is doing and vice-versa. Mr. Schick suggested that the presidents of the various musical groups might be able to rotate attendance at the meetings.

Michael would also like a Rosemont parent to be a liaison and attend meetings so that Rosemont families will know what is happening at the high school level.

1st Vice President – Fundraising: Kim Sandoval

Kim reported that the <u>Pizza Wars</u> fundraiser made \$3300. We are still waiting on numbers from the Town Centre <u>Dine-out Night</u>.

2nd Vice President – Performing Groups: David Jones

David reported that chaperones were needed for the Friday regional festivals and the upcoming Ensemble Concert.

3rd Vice President – Special Events: Fred Davis

Tomorrow is the last day to order <u>End of Year Banquet</u> tickets. <u>Graduation</u> is June 1st and volunteers will be needed to chaperone and to assist with instrument returns.
